ORDINANCE NO. 2007-4

GREENSBURG AVIATION COMMISSION

AN ORDINANCE OF THE COUNCIL CREATING A
GREENSBURG AVIATION COMMISSION

BE IT ORDAINED, by the Greensburg City Council, in the State of Indiana, as follows:

SECTION 1.

That the Council determines that a year-round airfield in the community is necessary for the health, safety, and well-being of the residents of the community, and therefore that a Greensburg Aviation Commission and Department, in terms of I.C. 8-22-2 is hereby created.

A. That such Greensburg Aviation Commission shall be composed of five (5) members, all of whom shall be appointed by the Mayor, City of Greensburg.

B. That the Greensburg Aviation Commission shall determine its total budget request and submit the same to the City Council of Greensburg, which shall determine the appropriation to be made.

C. That the Greensburg Aviation Commission shall elect a president and secretary from its membership who shall serve in such offices for a term of one (1) year. Such officers shall be elected annually at a Greensburg Aviation Commission meeting to be held in December of each year and such officers shall take office on the first Monday of the following year.

D. That monies appropriated by the City Council shall be deposited in a Greensburg Aviation Commission fund in the custody of the Clerk Treasurer of the City of Greensburg. Monies may be withdrawn only upon vouchers signed by the President and Secretary.

E. That the Greensburg Aviation Commission shall be empowered with all the powers granted to such boards by the statutes including, but not limited to those powers specified in I.C. 8-22-2.

F. That the Greensburg Aviation Commission shall have the authority to accept gifts of money or property, and may accept such gifts subject to conditions imposed by the donor, if the board determines that acceptance of such gifts is in the public interest.

G. That the Greensburg Aviation Commission is hereby authorized to accept assignment of a lease from the Greensburg Airport Trust, which lease is hereby incorporated herein by reference.

SECTION 2.


That this Ordinance shall be in full force and effect from and after its passage by the City Council.
