First order of business was to approve the September 24th, 2008 minutes

Corrections to the minutes were submitted by Mr. Matt Bailey. The changes were approved and corrections will be made and submitted into the September 24th minutes.

The board approved the minutes with all ayes with the exception of Mr. Dornich who declined since he was not present at the 9/24/08 meeting.

Mr. Ken Dornich was introduced and welcomed. He was sworn in prior to the meeting by the Mayor, Mr. Gary Herbert.

Approving the Claims

Last month the claim for Umbaugh in the amount of \$26,437.07 was denied pending an itemized bill. An itemized statement was received. Doug Fry had questions on an item from January. He was also concerned about getting double billed. It was recommended that they keep an eye on the bills carefully, and ask that statements of shorter time periods be sent in the future, as the statement covered charges from January to present.

Lowell Rethlake made a motion to pay the Umbaugh bill despite questions due to the fact they did what they were asked to do. Ken Dornich seconded. All ayes, motion carried.

Motion was made by Darrell Poling and seconded by Ken Dornich to pay Mainsource bank in the amount of \$222.00. All ayes, motion carried.

Motion was made by Darrell Poling and seconded by Lowell Rethlake to pay property acquisition to parcel 62 in the amount of \$23,600.00. All ayes, motion carried.

Bill Wenning asked about the utility issue for the Lincoln street project and increased cost. Clarification was given by Mr. Burkhart that some utilities in the right of ways have to be relocated and only if redesign is required would there be an increase in cost.

He also asked the Board how many condemnations they would be sending to the City Council. The answer was none.
