

BOARD OF WORKS MEETING  
JUNE 2, 2008

PRESENT: Mayor Gary Herbert, Steve Simmonds and Bill Wenning.

Pledge of Allegiance was recited.

All board members were present for roll call.

Minutes were approved.

The year 2008 cleaning service quotes were opened from the following with Insurance, equipment and supplies included:

1. Dove Cleaning Service ----- \$23,400 year-- 2x week City Hall & Police and \$28,600 year -- 2x week City Hall & 3x Police Dept.
2. Heaven Sent ----- \$ 35,360 year – 2x week City Hall & Police Dept.
3. Dan & Denise Manus ----- \$2225 per month (\$26,700 yr.) – 2x week City Hall & 3x Police Dept.
4. Office Pride ----- \$1992 per month (\$23,904 yr) – 2x week City Hall & Police Dept.

The Board will review the quotes and make a decision at the next meeting.

Jeff Smith Wastewater Superintendent informed the Board of the problem they have if downspouts and sump pumps are connected to the sanitary sewer lines and requested permission to send out letters to residences for their cooperation.

It was brought up that contractors would like to see a stub out on storm sewer lines to connect to in new additions and discussion was held.

Steve Teverbaugh addressed the Board about the possible closing of streets for the Fall Festival. He said that he would talk with the merchants and had talked with the Police and Fire Chiefs.

Fire Chief Scott Chasteen reported that Ladder Truck #6 has been put back in service.

Darren Burkhart of HNTB reviewed the status report on the current projects.
